

**Analysis (w/w): 7% Nitrogen (9.6% w/v) (all as Nitrate N),
4.3% Manganese (Mn) (6% w/v), 4.3% Magnesium (Mg) (6% w/v)**

Fielder M 'n M is a liquid foliar mix of Manganese and Magnesium, formulated using the highly available nitrate forms, for application to arable, horticultural and vegetable crops, to prevent and correct nutrient deficiencies.

Recommendations for use:

RATES OF APPLICATION:

Deficiency or severe stress:

Apply 2.5 Litres/ha as soon as there is sufficient leaf area or as soon as symptoms appear. Repeat every 14 days if required.

Maintenance:

Apply 1.5 litres/ha as soon as there is sufficient leaf area to absorb the spray.

Water Rate:

Conventional sprayer: 220 l/ha

Low Volume Sprayer: 55 l/ha

Fill the sprayer as required and commence agitation. Shake the container and add the required amount of product. Continue agitation whilst spraying.

Tank Mixing:

M 'n M is physically and chemically compatible with most pesticides. Check by mixing a small amount in the correct ratio adding the product to the water, followed by the pesticide. Crops can be susceptible to scorch from mixtures of M 'n M and pesticides applied during periods of rapid growth or stress.
