Magnesium 'C'

Contains : 4.0% Magnesium (Mg) w/w : 5.0% w/v.

A liquid complexed chelated formulation of magnesium purposely formulated to encourage rapid leaf uptake and maximum plant availability.

Recommendations for use:

Maintenance: Apply 2.5 l/ha (1.75 pints/acre) as soon as there is sufficient leaf area to absorb the spray.

Deficiency or severe stress: Apply 5.0 l/ha (3.5 pints/acre) as soon as there is sufficient leaf area or as soon as symptoms appear. Repeat every 14 days if required.

Cereals	2.5 - 5 L/ha	At start of tillering
Oil Seed Rape	2.5 - 5 L/ha	Start of spring growth
Potatoes	2.5 - 5 L/ha	Tuber initiation

Vegetables	2.5 - 5 L/ha	4 - 6 true leaves
Top Fruit	5 L/ha	At petal fall. Repeat every 14 days

WATER RATE:

Conventional sprayer : 220 litres/ha (20 galls/acre)

Low volume sprayer : 55 litres/ha (5 galls/acre)

TANK MIXING:

Fielder Magnesium 'C' is physically and chemically compatible with most pesticides. Check by mixing small amount in the correct ratio adding the product to the water followed by pesticide. Crops can be susceptible to scorch from mixtures of manganese and pesticides applied during periods of stress. Do not mix with MCPA, CMPP or products containing benazolin.
