Recommendations for use:

Deficiency or severe stress - Apply 5 l/ha (3.5 pints/acre) as soon as there is sufficient leaf area or as soon as symptoms appear. Repeat every 14 days if required.
Maintenance - Apply 2.5 l/ha (1.75 pints/acre) as soon as there is sufficient leaf area to absorb the spray.


Tank Mixing:

Fielder Magnesium + N is physically and chemically compatible with most pesticides. Check by mixing small amount in the correct ratio adding the product to the water followed by pesticide. Crops can be susceptible to scorch from mixtures of magnesium and pesticides applied during periods of stress. Do not mix with MCPA, CMPP or products containing benazolin.
