



# Manganese 15%

An inorganic liquid formulation of manganese purposely formulated to encourage speedy leaf uptake and maximum plant availability.

RL002A

Contains: Soluble Manganese (Mn) 11% w/w, (15% w/v)  
Sulphur Trioxide (SO<sub>3</sub>) 16.3% w/w, (22.2% w/v)

## Recommendations for use:

Deficiency or severe stress - Apply 3.5 l/ha (2.5 pints/acre) as soon as there is sufficient leaf area or as soon as symptoms appear. Repeat every 14 days if required.  
Maintenance - Apply 2 l/ha (1.5 pints/acre) as soon as there is sufficient leaf area to absorb the spray.

Sugar Beet	4 - 6 true leaves	3.5 L/ha
Peas and Beans	Immediately before flowering	3.5 L/ha
Vegetables	4 - 6 true leaves	2 - 3.5 L/ha
Soft Fruit/Top Fruit	At petal fall.	3.5 L/ha

## WATER RATE:

Conventional sprayer : 220 litres/ha (20 galls/acre)  
Low volume sprayer : 55 litres/ha (5 galls/acre)

## APPLICATION PRECAUTIONS:

Avoid spraying during high temperatures and bright sunlight. Keep out of reach of children. Avoid contact with skin, eyes or clothing. Wash exposed area with water. Prevent livestock access to treated area for 14 days.

## Tank Mixing:

Fielder Manganese 15% is physically and chemically compatible with most pesticides. Check by mixing small amount in the correct ratio adding the product to the water followed by pesticide. Crops can be susceptible to scorch from mixtures of manganese and pesticides applied during periods of stress. Do not mix with MCPA, CMPP or products containing benazolin.

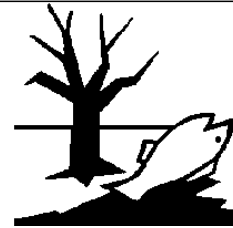
